WHEREAS, SDCL 10-23-2.3 provides that "The board of county commissioners may by resolution require that the name, address, and amount of taxes, penalty, and interest due and the years the taxes are due of any delinquent taxpayer whose real property was sold or offered for sale at a tax sale pursuant to SDCL Chapter 10-23 be published each year that a tax certificate is outstanding until such time as a tax deed is issued; and

**WHEREAS**, the Butte County Commission desires to require that the name, address, and amount of taxes, penalty, and interest due and the years the taxes are due of any delinquent taxpayer whose real property was sold or offered for sale at a tax sale pursuant to SDCL Chapter 10-23 be published each year that a tax certificate is outstanding until such time as a tax deed is issued.

**NOW, THEREFORE, BE IT RESOLVED** that the Butte County Commission hereby and herewith directs that the Butte County Treasurer, in July of each year, is to publish in the County's official newspaper, the name, address, and amount of taxes, penalty, and interest due and the years the taxes are due of any delinquent taxpayer whose real property was sold or offered for sale at a tax sale pursuant to SDCL Chapter 10-23 be published each year that a tax certificate is outstanding until such time as a tax deed is issued.
